### 2. Category of Membership Applied for (tick one only):

- Ordinary Members:** Comprising qualified counsellors, therapists, psychologists, psychiatrists and other related professional mental health practitioners with a Bachelor's degree or higher in counselling or clinical psychology and all Associate Members who have obtained a minimum of 30 contact Hours;
- Associate Members:** Open to all Christians. Those holding a Diploma in Counselling are given 15 Contact Hours at point of entry.

### Note :

- Ordinary Membership is for Malaysian citizens only. Foreign citizens can apply for Associate Membership only.
- Application for Ordinary Membership (and Diploma Holders) must be accompanied by a photocopy of the relevant certificate of tertiary qualification for approval of the NACC Membership Sub-Committee.
- The decision of the NACC Membership Sub-Committee is final. Applications not approved for Ordinary Membership will be registered for Associate Membership.
- An Associate Member (except for foreign citizens) must accumulate a total of 30 Contact Hours to be eligible to become an Ordinary Member.
- Contact hours are earned and awarded at the end of a conference session, workshop, lecture or other events as approved by the NACC Malaysia.
- The contact hours must be submitted to the NACC only when the required total of 30 has been accumulated.
- Only Ordinary Members are eligible to vote at the Association's Annual General Meetings and Extraordinary General Meetings.

**3. Membership Fees:**

Entrance (one-time payment) : RM100.00  
Annual Subscription (please refer note below)

**Note:**

- a. The Entrance Fee and Annual Subscription are payable upon application.
- b. Each application must be accompanied by a crossed cheque in the name of "National Asso of Christian Counsellors" or payment can be made online.
- c. Membership Application fees paid are non-refundable.
- d. The financial year of the Association is from Jan1 to Dec 31. Membership can be applied at any time of the year and the Annual Subscription is pro-rated in the first year (Join Jan-Mar – Rm100.00; April-June – Rm75; July-Sept – Rm50.00; and Oct-Dec – Rm25.00). Annual subscription for the following year and thereafter is Rm100.00.

**4. Certification:**

- a. I confirm that I have read the above and understood the contents.
- b. I am also aware that secularly qualified counsellors in Malaysia are registered under the Board of Counsellors Malaysia which does not recognise Christian Counselling. Hence, membership with the NACC does not qualify a Christian to set up practice as a professional counsellor.
